Cotton Seeds (Regulation of Supply, Distribution, Sale and Fixation of Sale Price) Act 2007, after careful consideration of the views of all stake holders in supply of Cotton Seed and considering the fact that BG-I and BG-II technology was brought to the Knowledge of World at large, several years back, Government have approved the proposal of Director of Agriculture, Telangana, Hyderabad in considering a reasonable trait value/Royalty along with other components as detailed below for the year 2015-2016.
