ORDER

The following Notification shall be published in the Telangana Gazette.

NOTIFICATION

In exercise of the powers conferred under clause 11 of the Seeds (Control) Order, 1983, and in supersession of the orders issued in the G.O. sixth read above, the Government of Telangana hereby appoint the Director of Agriculture, Telangana, Hyderabad to be the Licensing Authority for grant of licenses, renewals and amendments thereof for whole area of Telangana State in respect of Seed Companies and dealers who carry on business in seeds and having the sale premises and seed godowns in more than one district.

The District Agriculture Officers of respective Districts will continue to be the Licensing Authority for the whole area of the respective district for grant, renewal and amendment of licenses as notified in the G.O. 5<sup>th</sup> read above.

Further, in exercise of the powers conferred under sub clause (b) of clause 16 of the Seeds (Control) Order, 1983, the Government of Telangana hereby appoint the Agriculture Production Commissioner and Secretary, Agriculture & Co-operation Department as the Appellate Authority for State Level Seed License and the Director of Agriculture as the Appellate Authority for Dealer Seed Licenses issued by the District Agriculture officers.
